Veterans and family households.



### Message from Executive Director Shannon Boyle



Degree, increasing her overall household income, and ensuring her children's academic success.

Despite a diagnosis of autism and cognitive disabilities, a couple of years ago she strove to see her son graduate high school. This summer it was her daughter's turn but despite previous success in school, her goal was in jeopardy this past school year. Having wrestled medical issues for years, Carol's kidneys finally failed and she was placed on dialysis. It took a great deal to attend three long treatment sessions each week while continuing to work and maintain her household. Her children saw her struggles, and her daughter became anxious and worried for her mom's health and future. She found it difficult to focus on school and classwork when she thought her family was failing again and homelessness might return. Our program staff accompanied Carol and her daughter to various school meetings to strategize how to help. Her daughter met with their New Ground social worker alone to talk through her fears and concerns without having to worry Carol further.

Although it came down to the very end, in June Carol received confirmation from the school that her daughter would graduate. New Ground staff attended the graduation to cheer as she received her diploma and record this special moment, also celebrating her acceptance to a four-year SUNY program for September. It was a bittersweet day, as Carol was in the hospital recovering from kidney transplant surgery. She was unexpectedly notified by the organ donor list that she was up for a transplant but had to move immediately. She had her surgery just days before. Her daughter could not have been happier that mom witnessed her graduation by video and photographs, as she knew her mom was recovering and would soon have so much of her life back. This was more important than ever as the family has been selected by a first-time homebuyer program to become homeowners in the next two years.

Carol is recovering from her transplant and scheduled to return to work shortly. In September, her daughter began college outfitted with all necessary school supplies from our generous donors. Thus far, she is adjusting well and greatly enjoying her college experience.

This family's success was made possible by our many donors – thank you all for giving to New Ground in so many ways, providing the power of hope when it seems all is lost, and helping make dreams come true for all those we serve.
