THE VETERANS PROGRAM OFFERS INTENSIVE SOCIAL WORK SERVICES TO OVER 400 HOMELESS VETERAN HOUSEHOLDS IN NASSAU AND SUFFOLK COUNTIES PARTICIPATING IN THE NORTHPORT VA HUD-VASH PROGRAM, OR ON THEIR WAIT LIST. THE VETERAN HOUSEHOLDS HAVE BEEN CERTIFIED HOMELESS BY NORTHPORT VA AND PLACED IN HOUSING UNITS WILLING TO WORK WITH VA REQUIREMENTS AND ACCEPT THE VASH HOUSING SUBSIDY. VASH VETERAN HOUSEHOLDS MEET REGULARLY WITH A NEW GROUND SOCIAL WORKER TO RECEIVE COMPREHENSIVE SOCIAL WORK SERVICES IN THE FOLLOWING AREAS: FINANCIAL LITERACY, CAREER DEVELOPMENT, EDUCATION ASSISTANCE, EDUCATION ADVOCACY, READING ALL-STARS, TUTORING AND THE PARENT WORKSHOP PROGRAM. ALL CREATE INDIVIDUAL SERVICE PLANS OUTLINING GOALS TO SECURE STABILITY AND FUTURE INDEPENDENCE. VETERANS AND FAMILIES ATTEND MEETINGS AT THE VA, IN THEIR HOMES, AT NEW GROUND, OR OTHER CONVENIENT LOCATIONS.

THE JUMPSTART PROGRAM (JSP) PROVIDES NEW GROUND'S INTENSIVE SOCIAL WORK AND EDUCATION SERVICES TO ACTIVELY HOMELESS FAMILIES IN NASSAU AND SUFFOLK COUNTIES. EVERY JSP FAMILY MEETS WITH THEIR NEW GROUND SOCIAL WORKER ON A WEEKLY BASIS TO WORK TOWARD THEIR OUTLINED GOALS FOR FUTURE SELF-SUFFICIENCY AND INDEPENDENCE. ALL PARTICIPATING ADULTS CREATE AN INDIVIDUAL SERVICE PLAN OUTLINING THESE GOALS IN AREAS OF EDUCATION ADVANCEMENT FOR PARENTS AND CHILDREN, EMPLOYMENT, FINANCIAL LITERACY, CAREER DEVELOPMENT, PARENTING, LIFE SKILLS AND MORE. JSP FAMILIES ARE HOMELESS AND WORKING TOWARD PERMANENT, STABLE HOUSING.
