JSP FAMILIES MEET REGULARLY WITH THEIR SOCIAL WORKER TO MAKE PROGRESS ON SELF-DEFINED GOALS FOR FUTURE SELF-SUFFICIENCY AND INDEPENDENCE. GOALS FOCUS ON EDUCATION ADVANCEMENT FOR PARENTS AND CHILDREN, EMPLOYMENT, FINANCIAL LITERACY SKILLS, CAREER DEVELOPMENT, HEALTH, PARENTING, LIFE SKILLS, AND MORE. JSP FAMILIES ARE HOMELESS AND WORKING TOWARD PERMANENT, STABLE HOUSING. FAMILIES ARE REFERRED BY LOCAL HOMELESS SHELTERS, SCHOOL DISTRICTS, COMMUNITY BASED AGENCIES, AND THE DEPARTMENT OF SOCIAL SERVICES AND OTHERS.
